This rental agreement is for a complete LEGO Education WeDo 2.0 Core Set (45300).

RENTAL TERMS AND CONDITIONS:

- 1. The RENTER shall keep and maintain the rented equipment during the terms of the rental at his own cost and expense. He shall keep the equipment in a good state of repair, normal wear and tear excepted.
- 2. The equipment shall be returned to Northern STEM Robotics by the "Rental return date" listed above. If Northern STEM Robotics does not receive the kit 30 days after the return date, the renter will be responsible for the \$215 replacement cost minus any rental fees paid to date.
- 3. Northern STEM Robotics will not charge any member for normal loss of pieces. Normal loss is defined as loss of up to 15 individual LEGO bricks valued under \$2.00 each. Any loss or damage due to obvious mishandeling of the Tilt Sensor, Motion Sensor, Medium Motor, or the Smart Hub will require renter to pay replacement cost. If you have lost or damaged more than 40 pieces the renter will be given the choice to replace all missing pieces or purchase the set for \$215 minus any rental fees paid.
- 4. Renter has the option to purchase the set at any time for \$215 minus any rental fees paid so far.
- 5. Please note the WeDo set has small pieces and there is a choking hazard. Renter shall indemnify, defend and hold harmless Northern STEM Robotics, any officer or associate of Northern STEM Robotics from and against any claim, demand, cause of action, loss or liability (including attorney's fees and expenses of litigation) for any property damage or personal injury arising from Renter's use of Equipment by any cause, except to the extent caused by Northern STEM Robotics gross negligence or willful misconduct. The provisions of this Article shall survive the termination of this Agreement with respect to any claims or liability accruing before such termination. IN NO EVENT SHALL NORTHERN STEM ROBOTICS BE LIABLE FOR ANY INDIRECT, SPECIAL OR CONSEQUENTIAL LOSS OR DAMAGES ARISING FROM RENTER'S USE OF EQUIPMENT, INCLUDING BUT NOT LIMITED TO LOSS PROFITS AND LOSS REVENUE, EVEN IF INFORMED OF THE POSSIBILITY OF SUCH DAMAGES.
- 6. IN GOOD FAITH. Although Northern STEM Robotics makes no warranty of any kind regarding the Tilt sensor, Motion sensor, medium motor, or the Smart Hub. Northern STEM Robotics shall make every effort to replace pieces as soon as practical if the equipment fails to operate in accordance with the manufacturer's specifications. Please let us know as soon as possible to support you in a successful season.
